DIRECTIONS TO INSPECTION

From CT: Take 84 W toward Danbury (crossing into New York) Take the I-684 exit, Exit 20, toward RT-22/White Plains/Pawling. Merge onto I-684 N toward RT-22/Pawling/Brewster. I-684 N becomes NY-22 N. End at 2648.

From New York, NY: From I-95 N, take the I-87 exit, Exit 1C, toward Maj Deegan Expwy./Albany/Queens. Merge onto I-87 N via Exit 3 N toward Albany.

Take Exit 4 toward Cross County Pkwy. Stay straight to go onto Central Park Ave. Take the Cross County Pkwy. East ramp toward Bronx River Pkwy.

Take the ramp toward Hutchinson Pkwy. Merge onto Cross County Pkwy. E.

Cross County Pkwy. E becomes Hutchinson River Pkwy. N. Keep left to take I-684 N toward Brewster (passing through Connecticut), then crossing into New York. I-684 N becomes NY-22 N. End at 2648.
